**QUIET SUPERVISOR TO STEP DOWN  
DEMOCRAT LEFT GOVERNMENT IN HANDS OF PEOPLE**

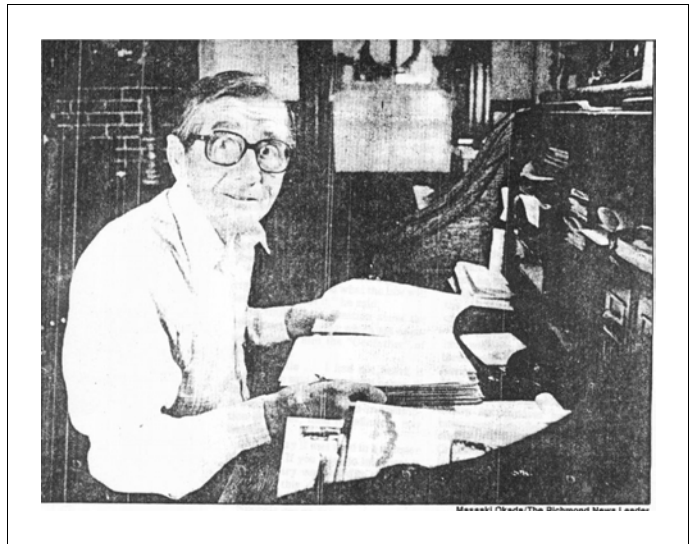
BEAVERDAM— During the past 18 1/2 years, A Page Nuckols has earned a reputation for sitting calmly and coolly on the Hanover County Board of Supervisors.

Only infrequently has he participated in the often heated debates among other supervisors. The only smoke he raises is from one of the cigarettes he frequently lights during a meeting.

But when he chooses to speak, Nuckols, a slight blond man, does so in a voice that rings clearly and distinctively. And he always can be counted on to make the motion to adjourn at the board's twice-monthly meetings. His motion always has a second. Nuckols, a Democrat who represents the rural Beavercreek District, believes that government should be left in the hands of the people. He will leave a segment of that government tomorrow when he steps down as a supervisor.

"I just figured I've been with the public long enough," he said during a recent interview. "I'd thought of hanging it up before now...."

But despite painful arthritis and cataract surgery performed within the past few years,

Nuckols has continued to serve the county, which has a population of more than 50,000.

What about his reputation for being relatively quiet during supervisors meetings?

"I'm not for sitting there arguing all day and all night", he said. "I'm down there to express the viewpoint of this community and not batter the breeze back and forth calling names."

His neighbors apparently agree with Nuckols. He was re-elected Beaverdam supervisor four times since his appointment to the board in 1965, when the county was expanded from 3 to 7 magisterial districts. "I've stood on my record," he said. Nuckols, 62, is critical of the amount of money local political candidates now spend when seeking a job that he feels has little power.

"The only power is deciding what's right and wrong and what the law will let you do about it," he said. He smiled at a question about the 1979 election, during which his opponent labeled him the "Godfather" of Beaverdam.

"That title....I had not heard it before," he said after a brief pause. "I think it was totally unfounded, and if it was meant to say it was an assumption of power, then it definitely was unfounded."

"I can't say it was used in a manner of respect. If you wish to interpret it to mean I try very hard to serve the people of this district and Hanover County, then yes....."

Nuckols got up from a chair in the kitchen of his large farmhouse to refill his pipe. He occasionally coughed in between recalling his earlier days as a supervisor.

"The Board was once rural and agriculturally oriented, but now we're getting into urban perspectives and priority ratings," he said. As a dairy farmer on 1,161 acres of land and a former agriculture teacher for Goochland and Hanover Counties, Nuckols is familiar with agricultural matters.

When Nuckols steps down, only two farmers will remain on the board—E C C Woods, Jr., who represents Henry District, and Nuckols' successor and former student, Aubrey M "Bucky" Stanley, Jr, who also is a lumberman.

Nuckols says he always has opposed tax increases, including a gross receipts tax on businesses. And although he left the classroom more than 20 years ago, Nuckols has kept up with educational issues.

"I think my record will show I voted against the first \$1 million school budget. Right now, we're spending about \$1 million a year in debt services for schools", he said.

"I think we've made wonderful strides with the schools, but I'm not associated enough with graduates to know the results we're getting," he said. "They're still going to school the same number hours a day, and I sometimes wonder if we're stressing the essentials."

# FREDERICK R. NUCKOLLS CONNECTION PROVED

**Frederick R. Nuckols** (probably stand for Reddy"), is the son of Nelson Nuckols and Mildred A REDDY. Nelson Nuckols was married to "Polly" Reddy. Polly appears in the 1850 Census with her eldest daughters, Nancy Ann, Mary and Elizabeth. The younger children in the household are Edward Jefferson age 10, Augustus, age 8, Sophia age 2 and a male baby (Frederick), age 4 months. ( The 1860 census name is Frederick, age 10). Polly at age 67 is too old to be having these children. I suspect that these MAY be illegitimate children of one of the daughters. The children continued to live with the daughters who never married . They appeared gain in 1860 and again in 1870. There was never a Mildred as head of house. Sisters Nancy and Mary are still alive in the 1880 Census living together with their nephew James Harris age 18. In 1880 Frederick was living with Pouncey Lafayette Nuckols, his cousin.

Strangely enough in the 1880 neighborhood is a Mary Nuckols age 75 and son Edward age 41. But Fredericks sister Mary is living with his other sister Nancy. If this is the Edward listed in the 1850 census, then it may be a clue as to their mother. We KNOW who the father is.

### Sam Nuckols Died In East After Attack

Versailles, Ky., Feb 5 (Special)--**Sam C. Nuckols, Jr.**, 27, of Versailles, former English instructor at the University of Kentucky, died at 10 o'clock this morning of a heart attack at the St. James hotel in New York City, according to word received here. Mr. Nuckols, who was attending the Benno Schneider dramatic school in New York, had been ill of influenza for the last several days.

He had attended the New York dramatic school since September 1940, and last summer appeared in several plays with the Summers Stock company at Cambridge Springs, Penn. Before going to New York, he was active in the Guignol theater at the University of Kentucky and appeared in "The Rivals," "Tovarich," "Volpone" and "Reunion in Vienna." He also directed "High Tor" and "R.U.R."

He was to have appeared in "The Man Who Came to Dinner" scheduled for production at the Guignol theater in April.

Mr. Nuckols received an A.B. degree from the University of Kentucky in 1936, with honors in English. He received his master's degree in 1938. He served as graduate assistant in the English department at the University in 1937 and in 1938 and then served two years as instructor. He was a member of the Kappa Alpha fraternity.

Mr. Nuckols was born Aug. 17, 1914, at Versailles. He is a son of Samuel C. and Lutie Smith Nuckols and was a member of the St. John's Episcopal church of Versailles. He graduated with honors from Versailles high school.

Besides his parents, he is survived by a sister, Miss Bettie Nuckols, of Versailles. His father left this morning by plane for New York to return the body to Versailles. Versailles Cemetery, Versailles

adjudged and decreed by the court that the trial of law mentioned in the bill be expressed to sale and that Geo. W. Cornett who is appointed a commissioner for that purpose do ex... to sale the said lands in front of the courthouse & 2 other places in Grayson County and sell the said land on credit of 6 months except costs of suit and expense of sale which he is to collect on day of sale, and take notes payable to himself commissioner and report to court.

A deed of bargain & sale from G. H. Mathews comr. to Creed Nuckolls was produced in court acknowledged by the said Mathews as his act and deed and ordered to be recorded. Creed and Clark Nuckolls, Plaintiffs against Elizabeth Craig In Chancery. This cause came on this day to be heard upon the bill the papers heretofore said, the former decree the report of G. W. Cornett and was argued by counsel and it appearing to the court that the report of said Cornett has been filed for 30 days and no exceptions having been taken, the same is received and confirmed by the court, and it appearing to the court from said report that

G. W. Cornett has sold the tract of land according to the former decree in this cause, but that Creed Nuckolls, has not paid the costs of suit and expense of sale nor executed his note to said Cornett for the Purchase money it is adjudged, ordered and decreed by the court that Creed and Clark Nuckolls pay to Geo. W.
