Israel Nuckols Home Saved

\$388,000 to purchase about 3 acres at 3501 Gayton Hills Lane.

Dee Dee Sullivan and her western Henrico County neighbors thought county officials would laugh at them.

Located in the Three Chopt District, the home on the site, called the Nuckols house, is believed to be one of the oldest buildings still standing in the county. Israel Nuckols bought the property in 1849, and six generations of the Nuckols family lived there.

In fact, when they first suggested asking the county to buy the historic property across from their homes and transform it into a park, they tossed it out there as a joke.

Fearing that a developer who had purchased the property would get approval to build town homes or single-family residential houses there and that the historical value of the home would be lost, Sullivan and others in the Graham Meadows and Gayton Station communities got involved.

"We totally did not expect this to work out the way it did," Sullivan said. "They like to build out here."

It took nearly a year, but this week Sullivan and her neighbors celebrated.

To Sullivan's surprise, the Henrico Board of Supervisors voted unanimously Tuesday to spend

property is assessed at \$316,300. It was last purchased by Gayton Hills LLC on April 27, 2004 for \$250,000.

Board members said the people who worked to save the site will have a say in how the park is developed. Many believe it should remain passive, with possibly a few picnic tables and have the house be the focus of

the park by possibly transforming it into a museum.

Supervisor David Kaechele, who represents the Three Chopt District, praised the neighborhood and the developer, Skip Gelletly, who planned to build on the site, for his cooperation. "This will be a great credit to the county in the future," Kaechele said

What may be the oldest structure still standing in Henrico County has been spared from a potential wrecking ball.

The historic Nuckols Farm house, which dates back to the late 18th century, was just shy of being replaced by nine single-family homes when neighbors in the adjacent Gayton Station and Graham Meadows communities stepped up to save it. After hearing their appeals over the past year, county officials have purchased the three-acre site for use as a future county park

Developer Skip Gelletly said some neighbors were receptive to his proposal, which evolved from townhouses to the single-family homes and would have required the two-story farmhouse and detached kitchen to be removed. Gelletly offered to relocate the house for preservation, but in the end, residents decided against the development and garnered the support of Three Chopt Supervisor David A. Kaechele to preserve the house at its original location. The county paid Gelletly

\$388,000 for the property. "I told people they could move it, but it would have been more a labor of love than a feasible economic solution," Gelletly said. "It's a responsible move by the county, and I feel comfortable that we worked with everybody. I'm happy that they're happy."

"It's a nice solution for the community and the county," Kaechele said. "There was a lot of cooperation from everybody, which is kind of unique. It's an ideal situation that'll seem to all work out."

Located just down Gayton Hills Lane from Nuckols Farm Elementary School in the Far West End, the farmhouse had been home to six generations of the Nuckols family until the early 1960s

Israel Nuckols bought the land in 1849, originally named "Locust grove," and the house was at one time home to as many as 17 family members. Among family buried in the Nuckols cemetery just beyond the farmhouse is Jacob Nuckols, who fought in the Confederate cavalry during the Civil War.

Descendants have since farmed acres throughout the area. G. Norwood Nuckols Jr., great-great grandson of Israel Nuckols, grew up on the farm that eventually became the Innsbrook Corporate Center. A Three Chopt representative on the Henrico Historic Preservation Advisory Committee, he serves as custodian of the cemetery at Nuckols Farm and said he is delighted that his family's history will be preserved intact.

This is my family's ancestral property. I visited up there a lot as a child," Nuckols said. "Up into World War II, there was more farming than anything else going on in the county. I consider my family to be one of the backbones of that farming community."

Nuckols concedes that residents involved in the preservation effort know more about his family now than many of his relatives do, as is apparent in their own observations of the property. "It's very interesting that it's made it this long," said Dee Dee Sullivan, one of the neighbors who rallied for the park. "It has a family cemetery - one of

the people buried there fought in the Civil War. And there's also an exterior kitchen building, which I think is one of three in the county. There's a lot of potential for telling a different story about the county's history."

It was Sullivan and her neighbors who first proposed the idea of turning the site into a park, and Nuckols supported their idea. Resident Michelle Keller called Alice Shulz, who represents Three Chopt on the county's parks and recreation advisory committee, who then leaned on Kaechele and representatives of the parks department. From there, Kaechele and county officials negotiated with Gelletly to purchase the property from him, and the developer agreed

The Henrico Division of Recreation and Parks intends to someday restore the exterior of the buildings and maintain the site as a passive, interpretive park. Residents involved said the county's decision was a pleasant surprise.

"I didn't want it to get developed at all. I had thought it couldn't be," Sullivan said. "I never thought our idea would be taken seriously." "I'm very pleased that the county was genuinely interested in getting the opinion of the neighborhood here," added neighbor Paul Szatkowski. "It is clear the county wants public input. I'm pleased they were receptive." "Dave Kaechele - he's the whole reason this happened," Keller added. "He's the one who's extended himself to preserve the heritage of the area. I compliment the developer, too. He knew that selling it to another individual would slate it for demolition in the future."

I always thought it could be a very special, historic park," she said. "It's amazing to think it was there during the Revolutionary War and the Civil War. We all learned through the history, and the link to that history is Norwood Nuckols." While the residents are pleased with the county's decision, so is the family descendant pleased with the efforts of his latest Henrico neighbors. "It's very unusual to me what these particular newcomers did," Nuckols said. "They really showed an interest. I feel quite honored they did it and impressed and amazed by it."

Mandan presents an Array of Handsome and Talented Candidates For JudgeThe judgeship question is warming up slightly this side of the river. The candidates so far brought to the forefront...Sam Nuchols of Mandan.

Bismarck Daily Tribune 22 January 1910

Mandan Brakeman Arrested For Assault An east end brakeman by the name of Smith was found guilty of assulting Attorney S L Nuchols by a local justice court Monday and was fined \$10 and costs. The defendant, however, threatens to appeal the case.The incident which caused the arrest of Smith transpired one day last week when Mr Nuchols was about to board No 4 for Bismark. No 16 also stood in the local yards and was scheduled to follow No 4 east. Smith claimed that No 4 was filled with passengers and that he should take No 16. Nuchols insisted on riding No 4 and Smith became hostile and committed the assault of which he was found guilty.

North Dakota Bismarck Bismarck Daily Tribune 17 July 1911

Judge S L Nuchols and family have returned from Knoxville Tenn where they have been a few weeks. Mrs Nuchols and the children went down with the intention of spending the summer. Their baby Samuel Junior, however was taken ill and the judge was summoned two weeks ago . The baby is much better but still slightly ill.

North Dakota Bismarck Bismarck Daily Tribune 09 October 1911

Judge Nuchols of Mandan was also in the city and he says he is not takling nor taking any part in politics, but is interested in the institution of the lodge of Elks which will take place in Mandan next Saturday night.

The initiation of Judge Nuchols was one of the great matters of interest. Many friends came to see the judge perform and there were some so mean that they wanted to see him become so gentled that he would eat out of their hand. The judge is a Tennessean and he likes to meet his adversary face to face.....When Judge Nuchols was through he turned to a friend and said that it was as mild and soothing as a Gladstone Hotel bed and Charlie Klaus handed the judge a really good cigar that he just happened to have

Builders of the Commonwealth by Col Ben G Whitehead-Judge Samuel L Nuchols

A decade counts for much in the great northwest, where a man is measured for what he is more than for what he has, and the career of Judge Nuchols has proven that the people were quick to recognize his fitness for the leadership which he has never abused. Judge Nuchols is a native of Tennessee, where he was educated in the law. He came to North Dakota and located in Mandan and from the first he found that success which will attend men of character and strength as well as ability. Within ten years of his coming here, Judge Nuchols was called to the district bench, and there too, he immediately displayed the qualities which have endeared him to those who have known him intimately. Learned in the law, a man of wide experience and great intelligence, he has taken a high place among the judiciary of the state , and the men of North Dakota are looking toward the gentleman from Morton for a great judicial career. The absolute honesty of this strong man , reared in the atmosphere of the Hermitage and profiting by the traditions which surround that historic spot, has made the people of not only of his district, but of the state at large, applaud the work that he is doing. He gave up a large law practice to go upon the bench, and the people appreciate his sacrifice. Judge Nuchols was from earliest manhood deeply interested in the military life of his native state and that interest attended his life in North Dakota. His proficiency was such, and his character so commended that he was made judge advocate general of the state militia with the rank of colonel, and his every duty was discharged in a way that would have brought pride to his old comrades in the southland. Judge Nuchols was married at Knoxville, Tenn in 1902 to Miss Minne Vance and three children have come to them .Judge Nuchols was city attorney of Mandan for six years. (Photo)
